Call to Order:

Chairman Robert Duval called Meeting #256 of the Air Resources Council (ARC) to order at 9:03 a.m. on Monday, January 14, 2019. Chairman Robert Duval announced that a quorum of the ARC was present.

Approval of Minutes:

David Cribbie entered a motion to accept the minutes of meeting #255. Mark Lambert seconded the motion, all in favor and the motion passed.

Division Activities and Legislative Update:

Chairman Robert Duval introduced Director Craig Wright of the Air Resources Division (ARD). Director Craig Wright briefly updated members of the ARC regarding issues relative to the ARD, including:

Permitting Update:

• On December 6, 2018 Department of Environmental Services held their Annual DES Award Ceremony and Air Resources employee Cathy Beahm, our Air Permit Programs Manager, received the David S. Chase Award for Extraordinary Achievements in Science. This award is named in honor of the late David Chase, who passed away very unexpectedly in November, 2008. David served as the Radon Program Manager at NHDES and the Department of Health and Human Services for over 16 years. David was extremely dedicated and devoted to the radon program and, under his guidance; New Hampshire's radon program received national and international recognition.

For over two years, Cathy has been the go to person for Air Resources Division for the Southern NH PFAS investigation. A particularly challenging issue has been the significant lack of data on specific types of PFAS and precursors currently being emitted into the air. While this has caused many states to wait until other federal agencies (such as EPA) are able to gather more information, Cathy recognized the urgency of the potential implications to public health and undertook an effort to increase her knowledge. She reached out to partners in other states, and also engaged the EPA Office of Research and Development (ORD) and established a very effective partnership, which has helped NHDES with laboratory expertise, and increased the knowledge base of both agencies. Cathy's work culminated in her organization of a two-day NHDES/ORD meeting that was incredibly beneficial to both agencies' understanding of PFAS in the environment. Due to her extraordinary efforts, she has quickly become a leading authority on PFAS and continues to be an invaluable resource both to NHDES and other environmental and public health agencies.

- <u>Public Hearing draft Title V Operating Permit for Bridgewater Power</u>: In September, ARD commenced a 30-day public comment period on the draft Title V Operating Permit renewal for the Bridgewater Power Company facility. Written comments were received on the draft permit, and we also received a number of requests for a public hearing. The public comments and hearing requests mentioned concerns about emissions of particulates, heavy metals, and also requested more information on VOCs, NOx, and air pollution controls. In response, we held a public hearing at the Bridgewater Town Hall on December 13th. In accordance with NH Administrative Rule Env-A 622.08 *Decisions*, NHDES has 30 working days to issue a final decision on the permit; ARD will issue a decision by January 24, 2019.
- Director Wright said that 2 of the 4 citizens who requested a public hearing did not attend the hearing (and the 2 others were late to the hearing we were ready to close the hearing when they arrived). In the *Findings of Fact and Director's Decision*, NHDES plans to note the considerable time and expense that NHDES goes through to prepare and conduct a public hearing, and while we are happy to do so, that the expectation is that those who request a hearing will in fact attend.
- Proposed Title V Operating Permit for Wheelabrator Concord: On September 5, 2018, the ARC issued a Decision and Order on State's Motion to dismiss the appeal of Kaplan et. al., which denied the appeal. On November 26, 2018, the ARC denied a Motion for Reconsideration on the September 5 decision. NHDES subsequently requested EPA to reinitiate its 45-day review of the Proposed Title V Operating Permit, starting on November 29, 2018. However, before the 45-day review period ended, the federal government shutdown went into effect, furloughing the EPA staff that would review the Proposed Permit.

Environmental Health Program Update:

Water standards for PFAS: At the last ARC meeting in November, we discussed Senate Bill 309 (SB309), which regulates groundwater pollution caused by air emissions and also requires NHDES to establish water standards for perfluorochemicals. SB 309 also authorized General Funds for NHDES to hire a toxicologist and a health risk assessor to complete the tasks in the bill; both of whom started on October 12th.

NHDES proposed the water standards for PFAS on December 31, 2018, in accordance with the deadline specified in the bill. The following standards were proposed:

NHDES is providing an approximate 60-day period to review the proposed standards and their basis. At least 3 public hearings will be held in March on the proposed rule. Assistant Commissioner Freise and Dr. Jonathan Ali (our new Toxicologist) are also conducting a couple of technical sessions on the proposed standards in the Merrimack and Portsmouth areas the week of January 14th.

Status of Appeals

Paula Scott, Appeals Clerk briefly updated members of the two recent appeals to ARD, including:

Docket No. 18-02 ARC- Anthony Caplin, et al Appeal

November 26, 2018 issued Decision and order denying Appellants "Motion for Reconsideration. Docket No. 18-02 ARC- Anthony Caplin, et al Appeal is now closed.

Rules

Air Resources did not have any new rules to bring to the council at this time, therefore Chair Robert Duval thought that this would be a good time Review Env-AC200 Procedural Rules for Air Council to review. The following rules were discussed by the council, including:

EcX 102.09 "Department enforcement decision" means "department decision" as defined in RSA 21-O: 14, Ic Director Wright suggested verification that this is sufficient to Air Council.

EcX 203.01 <u>Initiating an Appeal</u>. As required by RSA 21-0:14, the notice shall be filed within 30 days of the date of the decision. Council member Elizabeth Tillotson asked for an explanation or if this was up to the Air Council to decide. Chair Bob Duval stated that the Council should add a paragraph D added with a better explanation.

EcX 207.15 <u>Reopening of the Record.</u> Paragraph (c) If the hearing officer determines that such testimony, exhibits, or arguments are necessary to a full consideration of the issues raised by the appeal, the record shall be reopened to accept the offered items. Chair Robert Duval feels that the final decision should be made after the hearings officer consults with the Air Council.

EcX 208.06 <u>Consideration of a Motion for Rehearing.</u> Paragraph (a) The hearing officer shall, no sooner than 7 days after receipt of a motion for rehearing, either:

- (1) Grant the motion and either:
 - a. Schedule a rehearing; or
 - b. Grant the relief requested; or
- (2) Deny the motion and affirm the decision that was issued

Chair Robert Duval again stated that this also should be a decision between the hearing officer and Air Council together. Director Craig Wright stated that the wording of "no sooner than 7 days after" in 208.06 should state "within 7 days after".

Chair- Robert Duval advised the council that they should work diligently together for the next Air Council meeting that is scheduled for Monday February 11, 2019.

Chairman Robert Duval called Meeting #257 of the Air Resources Council (ARC) to order at 9:03 a.m. on Monday, March 11, 2019. Chair Robert Duval announced that a quorum of the ARC was present.

Approval of Minutes:

Chair Robert Duval entered a motion to approve the minutes of meeting #256. Motion moved by Vice Chair David Collins and seconded by J. Ryan Bielagus. Air Council all in favor.

Division Activities and Legislative Update:

Chairman Robert Duval introduced Director Craig Wright of the Air Resources Division (ARD). Director Craig Wright briefly updated members of the ARC regarding issues relative to the ARD, including:

Permitting Update:

New Permit Engineer: ARD's Permitting Unit recently hired Lisa Camire as a permit
engineer. Lisa has a Bachelor in Science in Environmental Engineering from Rensselaer
Polytechnic Institute (RPI), and joins ARD after spending 20 years working for General
Electric Power and Water. In Lisa's most recent position she assisted with commissioning
power plant projects, including assisting with permits and emission testing. Lisa also has
worked on a couple of groups which she was able to comments on the EPA Clean Power

Plan rule and rule updates for New Source Performance Standards for large boilers (Subparts Db and Dc). Her experience working with power plants should greatly benefit the Division.

- Title V Operating Permit for Bridgewater Power: In September2018, ARD commenced a 30-day public comment period on the draft Title V Operating Permit renewal for the Bridgewater Power Company facility. A public hearing was subsequently held on December 13, 2018. Written comments were also received on the draft permit. NHDES issued a Proposed Title V Operating Permit on January 24, 2019. The 30-day deadline for an appeal to the Council has passed.
- Title V Operating Permit for Wheelabrator Concord: On September 5, 2018, the ARC issued a Decision and Order on the State's Motion to Dismiss the appeal of Kaplan ET. al., denying the appeal. On November 26, 2018, the ARC denied a Motion for Reconsideration on the September 5 decision. NHDES subsequently requested EPA to re-initiate its 45-day review of the Proposed Title V Operating Permit, starting on November 29, 2018. However, due to the federal government shutdown, review of the Proposed Permit was delayed. EPA finally completed its 45-day review, and the final Title V Operating Permit was issued on January 24, 2019.

Environmental Health Program Update:

• Water standards for PFAS: At the November and January ARC meetings, the ARC discussed Senate Bill 309 (SB309), which regulates groundwater pollution caused by air emissions and also requires NHDES to establish water standards for perfluorochemicals. SB 309 also authorized General Funds for NHDES to hire a toxicologist and a health risk assessor to complete the tasks in the bill; both of whom started on October 12th. NHDES proposed the water standards for PFAS on December 31, 2018, in accordance with the deadline specified in the bill. The following standards were proposed:

NHDES provided an approximate 60-day period to review the proposed standards and their basis. 2 of the 3 scheduled public hearings were held March 4th and 5th, with the final hearing in Portsmouth to be held March 12th.

Rules: Proposed Readoption of Env-A 1000, Prevention, Abatement, and Control of Open Source Air Pollution

Karla McManus, Planning and Rulemaking Manager Linda Magoon, Senior Compliance Assessment Specialist

ARD is proposing to readopt and amend Env-A 1000, *Prevention, Abatement, and Control of Open Source Air Pollution*. There are only a few amendments proposed for this rule.

Specifically, Env-A 1001, Open Burning, sets forth general open burning requirements, definitions, and a list of materials that are allowed to be burned in the state, and lists absolute prohibitions against the burning of certain types of materials, including the statutory ban (RSA 125-C:10-c) on burning the wood component of construction and demolition debris and a prohibition against off-site transport of brush for open burning. Env-A 1002, Fugitive Dust, has been clarified to make sure that emissions generated by specific activities are covered and precautions for limiting fugitive dust are listed. Env-A 1003, Firefighter Instruction and Training Activities, still establishes the procedures for limiting the emissions of particulate matter and toxic air pollutants from firefighter instruction and training activities with only minor edits.

Vice Chair David Collins motioned to start a 15 day review of Proposed Readoption of Env-A 1000, Prevention, Abatement, and Control of Open Source Air Pollution and Mark Lambert second the motion. All were in favor of starting the 15 day review.

The Regional Greenhouse Gas Initiative (RGGI) RGGI is composed of individual CO2 Budget Trading Programs in each of the nine RGGI participating states. Each participating state's CO2 Budget Trading Program is based on the 2008 RGGI Model Rule, which was developed to provide guidance to states as they implemented the RGGI program. RGGI participating states completed a 2012 Program Review and made amendments to the 2008 RGGI Model Rule which were finalized in February 2013. RGGI participating states completed another Program Review in 2017 which resulted in amendments to the RGGI Model Rule, finalized in December 2017.

In response to changes made to the RGGI Model Rule in 2017, the New Hampshire Legislature proposed amendments to RSA 125-O:8, and RSA 125-O:20-29, and Governor Sununu signed them into Law on July 11, 2019. The amendments will go into effect on January 1, 2020.

The proposed rule implements the changes to the Model Rule and the above-referenced Statutes. Specifically, the Statute repeals the Carbon Dioxide (CO2) Offset Projects portion of RGGI, the Env-A 4700 rule, in New Hampshire. As a result, the Env-A 4700 rule is being repealed and the reference to Env-A 4700 in Env-A 4801.03 is being deleted. Major changes to the NH Law, and proposed amendments to our Env-A 4600 RGGI Rules, are attached (see the regional summary at https://www.rggi.org/sites/default/files/Uploads/Program-Review/12-19-2017/Summary Model Rule Updates.pdf).

Chairman Robert Duval introduced Assistant Director Mike Fitzgerald of the Air Resources Division (ARD). Assistant Director Fitzgerald briefly updated members of the ARC regarding issues relative to the ARD, including:

• <u>Public Hearing - Draft Temporary Permit for Installation of Air Pollution Control Equipment at Saint-Gobain Performance Plastics, Merrimack, NH:</u>

On November 5th, the Permitting Department held a public hearing in Merrimack on a draft Temporary Permit for Saint-Gobain Performance Plastic Corporation. The permit would authorize Saint-Gobain to install air pollution control equipment to control perfluorinated

compounds (PFAS). RSA 125-C:10-e, *Requirements for Air Emissions of Perfluorinated Compounds Impacting Soil and Water*, requires facilities that emit certain PFAS (or precursors) to the air that have caused or contributed to an exceedance of an ambient groundwater quality standard or surface water quality standard to install "best available control technology (BACT) for air emissions".

Approximately 100 people attended the hearing, with 20 people providing oral testimony on the draft Temporary permit. We also received many written comments.

NHDES has extended the public comment period on the draft Temporary Permit to **December 6, 2019**. Once the public comment period closes, Saint-Gobain has 10 working days to respond to written comments (if they wish to do do). NHDES then has 30 working days to review the comments, prepare responses, and issue a final decision.

• Public Hearing - Draft Temporary Permit for RUDARPA, Inc., Bethlehem, NH:

On December 12th, ARD will hold a public hearing in Bethlehem on a draft Temporary Permit for Rudarpa Inc. They have applied to install a system to convert landfill gas (LFG) from the adjacent landfill (owned and operated by North Country Environmental Services) into high BTU content natural gas. The gas would then be compressed for loading to tanker trucks.

• <u>USEPA Denial of Citizen Petition on the Wheelabrator Concord Title V Operating</u> Permit:

On January 2nd, 2018, ARD issued a Proposed Title V Operating Permit to Wheelabrator Concord. This permit was appealed to the Air Resources Council (Docket No. 18-02 ARC); the Council ultimately denied the appeal in November 2018. The USEPA's 45-day review of the proposed permit ended on January 14, 2019, during which time the USEPA did not object to the Permit. NHDES issued the final Permit on January 24, 2019. A Title V Petition was subsequently filed on March 14, 2019. On 10/30/2019, the EPA Administrator denied the Title V Petition.
